Objectives:

- (1) To be the governing body of Shorinji-Ryu Karate do in India.
- (2) To promote and develop nationwide the true art and spiritual culture of Karate-do for physical culture, self-defense and amateur sport.
- (3) To develop mutual understanding, mutual respect, spirit or unity, goodwill and friendship among members and those interested in karate-do.
- (4) To promote and organize regional/state/district/national championships, demonstrations seminars, camps etc.
- (5) To standardize and control the quality of instructors for the betterment of the standard of karate-do and to arrange for instructions in karate-do to interested persons throughout India.
- (6) To represent the country in State/National/International meetings and championships.
- (7) To promote the standards of Shorinji-Ryu karate-do competitions and rules of refereeing and judging in accordance with amateur laws.

RULES AND REGULATIONS

Articles 1:

- (I) STATE STYLE CHIEF MEMBERSHIP: Qualification to become a Style Chief shall be as follows:
 - Any state members can become state style chief member.
 - State members should follow the rules and regulation of our system.
 - State members should obey the order of President & Chief Instructor
 - State members should fill the application and submit to the Head Office.

Articles 2:

- (II) SUBSCRIPTIONS
 - State Style Chief Membership shall pay Rs. 10,000/- for the first year and Rs.5000/- annually thereafter.
 - Subscription becomes due in January each year and should be made payable to MYKARATE.

Articles 3:

- (III) GOVERNING BODY
 - There shall be a governing body of not more than "15" and not less than "7" members.

- Members shall be elected at the Annual General Meeting of the organization or an Extra Ordinary General Meeting of the organization.
- Office bearers of the Governing Body shall consist of President & Chief Instructor, National Director, Technical Director, Vice President, General Secretary, Joint Secretary, Organizing Secretary, Women's Director, Public Relationship Director etc.
- The President & Chief Instructor may only hold office continuously for life time.
- The Office bearers shall be elected by the governing body form amongst themselves.
- Office of the National Director & Technical Director shall be permanent.

Articles 4:

(IV) DUTIES OF THE OFFICE BEARERS

- The President & Chief Instructor shall preside over the meeting of the general body and executive committee. In the absence of the President & Chief Instructor one of the members nominated by the President & Chief Instructor shall act in his place. In the absence of the President & Chief Instructor and nominated National Director or Technical Director will preside over that meeting only.
- The National Director & Technical Director to look after the welfare of the Organization and manage the same in accordance with its rules and regulations and the directions of the General Body and the Executive Committee.
 - To oversee the office of the Organization and its properties.
 - To carry on correspondence on behalf of the Organization.
- The Other Members (Vice-President, General Secretary, Joint & Organizing Secretary and Women's Director) to undertake the proper training of the federation.
- The Public relationship Director (PRD) is about managing reputation of the Organization. PRD to look after planning publicity strategies and campaigns. writing and producing presentations and press releases. dealing with enquiries from the sponsors, the press, and related organizations. organizing and attending promotional events such as press conferences, open days, exhibitions, tours and visits. **(Note:** Remuneration will be given based on the sponsorship activity. If any sponsors providing any funding to the organization recommended by Public relationship Director (PRD). After depositing the fund to organization 10% will be handover to the Public relationship Director (PRD) as remuneration.

Articles 5:

(V) MEETING

- A meeting of the Governing body shall be held once in six months at such place and time as the President or National Director or Technical Director may determine.
- The President shall preside over all meetings of the Governing body and in his absence National Director or Technical Director shall elect as a meeting chairman.

Articles 6:

(VI) TERMINATION

- If any members disobeyed or collected extra fees from parents, immediate termination from the organization.
